To whom these presents shall come, greeting. Know ye, that in consideration of the ancient compo-
-sition of One pound five shillings Sterling paid by Enoch Osborne into the Treasury of this Commonwealth,
there is granted by the said Commonwealth unto the said Enoch Osborne, a certain Tract or parcel of Land
containing Two hundred and eleven acres, by survey bearing date the sixteenth day of December one
thousand seven hundred and seventy four, lying and being in the County of Grayson, on the West side of
New River, and being part of an Order of Council granted to the Loyal Company, to take up and
survey Eight hundred thousand acres, which Order was Established and confirmed by a decree of the
Court of Appeals made in the City of Richmond on the second day of May in the Year of Our Lord one
thousand seven hundred and eighty three, and bounded as followeth to wit. Beginning at two Spanish
Oaks and a White Oak on the top of a hill, and running thence South seventy one degree East seventy six
poles to two Spanish Oaks and a White Oak sapling on the top of a ridge, South twenty six degrees East
two hundred and forty three poles to two White Oaks and a White Oak sapling on the River Banks above
the mouth of a Creek, near where the River makes a short bend, thence up the meanders thereof
two hundred and fifty nine poles to all White Oak and black Walnut on the bank, thence leaving
the River South twenty six degrees East one hundred and eighty nine poles to the beginning: With
its appurtenances To have and To hold the said Tract or parcel of Land with its Appurtenances to
the said Enoch Osborne and his Heirs forever. In witness whereof the said Robert Brooke Esquire
Governor of the Commonwealth of Virginia, hath hereunto set his Hand and Cause the lesser
seal of the said Commonwealth to be affixed at Richmond on the second day of April in the
Year of Our Lord one thousand seven hundred and seventy five, and of the Commonwealth

To all to whom these presents shall come,
Greeting: Know Ye, that in conformity with a survey made the 17th day of December 1744, and in consideration of the Composition of thirteen shillings and four pence paid into the Treasury of this Commonwealth, there is granted by the said Commonwealth unto Enoch Osborn senior, Assignee of James Poyser heir at law to Elizabeth Poyser, deceased, a certain tract or parcel of land containing Sixty acres, situate in the County of Grayson (formerly Fincastle) on the west side of New river and bounded as followeth to wit Beginning at two spanish oaks on the top of a hill by a small branch thence South ten degrees West forty four poles to a hickory and black oak on the river bank thence up the same with the meanders thereof and binding thence three hundred and twenty poles to a black oak, thence leaving the river North fifty seven poles to a spanish oak and white oak sapling North eighty nine degrees East seventy poles crossing a branch, to two white oaks and a spanish oak at the foot of a hill, and thence South seventy five degrees East two hundred and thirty eight poles along said hill to the beginning; To being part of an Order of Council granted to the Royal Company to take up and survey Eight thousand acres which order was established by a decree of the Court of Appeals made in the City of Richmond on the second day of May 1783. To have and to hold the said tract or parcel of land, with its appurtenances, to the said Enoch Osborn and his heirs forever
IN WITNESS whereof the said Wilson C. Nicholas Esq. Governor of the Commonwealth of Virginia hath hereunto set his hand and caused the laper seal of the said Commonwealth to be affixed at Richmond, on the 3rd day of July in the year of our Lord, one thousand eight hundred and sixteen, and of the Commonwealth the fortieth.
